Placenta Essex UK provide placenta services including encapsulation, tinctures, cord keepsakes and the sourcing of homeopathic placenta remedies.

PRN members have been trained and certified by a PRN accredited trainer to provide placenta services to the public.

Placenta Essex UK is fully insured with BGI UK.

Placenta Essex UK purpose built premises have been inspected and authorised by the local council environmental health to provide your remedies.

Whilst not mainstream the benefits of consuming one's own placenta post-birth are based on research studies, articles and testimonials. Research is ongoing and the specialist does not give any warranty or representation that benefits are guaranteed.

Clients who utilise these services take full responsibility for their own health and for researching and using the products created from their placenta.

The client agrees that neither PRN or Placenta Essex UK is liable, and they do not take responsibility for any effects the client may experience before, during or after consuming the products unless resulting directly from negligence of the Specialist.

PRN recommends clients' placenta products are solely for their own use.

Placenta Essex UK will not provide services for clients who have ever tested positive for HIV/AIDs, Hepatitis B, Hepatitis C and/or CJD.

All methods of decontamination and disinfection of equipment used by PRN members adhere to Government guidelines and regulations.

The client agrees to open the cool pack when received, store the gel packs in their freezer until required and read the instruction cards provided in full to familiarize them/birthing partners with the process of safe storage and liaison with Placenta Essex UK.

Placenta Essex aims to prepare the placenta within 3 days of its collection, usually within 12 hours - however no guarantee can be given and will be communicated.

The client agrees to notify Placenta Essex UK during labour, and within 1 hour of the birth of the placenta to allow for collection arrangements to be made.

The client agrees to store their placenta in the Safe Storage Pack provided by Placenta Essex UK or in a refrigerator within 30 minutes after birth of the placenta and agrees to ensure her placenta remains chilled until collection.

Collection will be made within 12 hours of notification to Placenta Essex UK

The client is advised that if their baby is born during the hours of 11pm-7am to notify Placenta Essex UK using the contact method provided and that contact will be made after 7am to arrange the collection.

If for any reason the placenta is not suitable for consumption, you may be offered an alternative method. If on medical grounds your placenta is not fit for consumption the balance minus deposit will be refunded. If instruction are not followed, and the placenta is not suitable on the grounds of storage or mishandling by the client a refund will not be issued.

The midwife in charge and delivering hospital will not be able to give advice on the procedures or instructions from Placenta Essex UK, and all questions should be directed to us before, during and after delivery.

The client consents to the removal of the placenta from the hospital (or home) by the specialist to the extent necessary for the performance of the-services.

Homeopathic remedies may be re-ordered via the PRN homeopath, who will keep a 1C copy of the client's original sample for 5 years.

The client consents to the safe disposal of the original placenta sample when used for homeopathic remedies unless the client indicates in advance on the booking form that they would like the sample returned. Fees apply.
